In the research review A New Wave of Evidence: The Impact of School, Family, and Community Connections on Student Achievement, Anne T. Henderson and Karen L. Mapp concluded that there is a positive and convincing relationship between family involvement and student success, regardless of race/ethnicity, class, or parents' level of education.

Their recommendations were the basis for an update to PTAs National Standards for Family-School Partnership and are available to all PTAs.
